The project will provide targeted flood mitigation by installing additional parallel storm sewer lines and a Green Street bioretention facility along N. Kennebec Street and 11th Road North to enhance the conveyance capacity of the existing system, reduce surface flooding during storm events, and deliver measurable water-quality benefits by removing sediment and nutrients. The project modernizes critical aging infrastructure, improves public safety, and supports long-term flood resilience.

The project will directly benefit approximately 602 households within Census Block Group 510131009004, where improvements will be located. The area includes single-family homes and multifamily buildings, including several designated as affordable housing communities. Flooding during the July 2019 event caused major damage at multiple addresses, including 1110 N. Kenilworth Street and 5716 11th Road North. The proposed improvements from the project will reduce flood risk to homes, improve access to nearby parks and community facilities, and strengthen neighborhood resilience.

**Critical Facilities/Infrastructure\*:**

The stormwater infrastructure along this corridor serves as a trunk line for the Four Mile Run watershed, a 9.4-square-mile drainage area that is a significant feeder of the Potomac River, which ultimately carries the water flowing from Four Mile Run to the Chesapeake Bay. The Four Mile Run is a key receiving waterway identified in Arlington County's watershed management framework for targeted stormwater and water quality improvements. Runoff from approximately 100 acres converges at the project location before discharging to the Four Mile Run open channel south of the project site.

**Financial and Staff Resources\*:**

Arlington County has successfully delivered multiple gray and green infrastructure projects within the last five years. The County has technical and financial staff with experience managing state and federal infrastructure grants. Key staff members include John Clemons (Project Manager), Jennifer Tastad (Design Team Supervisor), Christopher Balallo (Design Team Supervisor), Christin Jolicoeur (Principal Environmental Specialist), Anne Guillette (Associate Environmental Specialist), Amanda Junge (Design Engineer), Ismael Nunez (Design Engineer), Lily Whitesell (Stormwater Outreach Specialist). The County uses AutoCAD Civil 3D, Trimble Unity Construct, and Microsoft Office Suite for design and management. The staff will be supported with any tasks outside their scope or availability by on-call professional service contracts.

**Goals and Objectives\*:**

The project has three main objectives:

? The Project will seek to reduce flooding at the intersection of Kennebec Street and 11th Road North through an upgraded stormwater system. A modernized, climate-resilient design will prevent localized flooding and reduce damage to residential and multifamily properties in the area.

? The Project will modernize aging stormwater infrastructure by replacing undersized pipes with a system capable of transporting larger storm events without overflowing. Upgrading the system will reduce the risk of failure, improve long-term reliability, and lower maintenance costs for the County.

? The Project will improve water quality and stormwater management through the installation of a bioretention rain garden. The system will capture and filter runoff, removing nutrients and sediments before returning water to the stormwater network, ensuring environmental compliance and long-term performance.

**Relationship to Other Projects\*:**

The County is collaborating with the Center for Watershed Protection (CWP) on a National Fish and Wildlife Foundation (NFWF) grant entitled ?Scaling Up Biochar in the Chesapeake Bay.? We will use Biochar-Enhanced Filter Media (BEFM) in the bioretention. Biochar, a solid, charcoal-like material created by burning biomass, or organic material in an oxygen-limited environment through the process of pyrolysis, has been demonstrated to enhance runoff reduction by increasing soil porosity, water holding capacity, and infiltration rates.

Phase II of this project involves the upsizing of the existing storm sewer conveyance system upstream in the watershed. The system will be upsized and rerouted in the vicinity of Wahington Boulevard and N Illinois St/N Inglewood St to resolve flooding concerns in that area. As these Phase II improvements will result in more runoff

being conveyed downstream to an area already experiencing flooding, the Phase I improvements must be implemented first.

**Criteria\*:**

1. Project Type: Hybrid approach resulting in nature-based solution (15 points). The project uses a hybrid approach combining gray and green infrastructure, including larger storm drainpipes and a bioretention rain garden, to deliver a nature-based flood mitigation solution.
2. Social Vulnerability Index Score: Moderate social vulnerability of 0.05 (5 points). The project area has a moderate SVI score, with a score of 0.05 according to the Virginia Flood Risk Information System (VFRIS). However, the immediate community has heightened vulnerability due to a median household income of \$50,798, significantly below Arlington County's median income of \$140,160. The Project area's lower median income relative to the county's high cost of living thresholds could make it more difficult for residents in the project area to recover from the impacts of flooding.
3. Community Scale of Benefits: More than one census block (30 points). The project benefits neighborhoods in the Census Block Group 510131009004, protecting approximately 602 households and 4,209 residents while improving accessibility and public safety. Additionally, the project provides benefits for community members traveling to or through adjacent public spaces. The project will reduce flood impacts in Bon Aire Park downstream, reducing washouts and hazardous conditions at the trail connection linking the neighborhood to the Custis Trail, an area confirmed by the County to experience flooding during storm events.
4. Expected Lifespan of Project: 50-70 Years (10 points). The upgraded stormwater system and bioretention facility are designed for long-term performance and will be maintained under the County's Stormwater Management Maintenance Contract, ensuring a lifespan between 50-70 years.
5. Remedy for NFIP probation or suspension: No. (0 points) The project does not serve as a remedy for NFIP probation or suspension.
6. Proposed project part of a low-income geographic area: Yes (10 points). The project area has a median household income of \$50,798 (ACS 2023), less than half of Arlington County's median income of \$140,160 (ACS 2023).
7. Proposed project implements a Chesapeake Bay TMDL BMP: Yes. (5 points). The project implements a Chesapeake Bay TMDL best management practice through the bioretention rain garden, which reduces nutrient and sediment pollution entering Four Mile Run and the Potomac River.
